



Privacy Notice for Miriam Shalom

Thank you for choosing to instruct me in your case. I will need to collect and hold your personal information in order to represent you. I will take all possible steps to protect your personal information. I am determined to do nothing that would infringe your rights or undermine your trust. This Privacy Notice describes the information I collect about you, how it is used and shared, and your rights regarding it.

Data Controller

I am registered with the Information Commissioner's Office (ICO) as a Data Controller for the personal data that I hold and process as a barrister. My registered address is Field Court Chambers, 5 Field Court, Grays Inn. London WC1R 5EF and my registration number is Z9214558.

Data Collection

The vast majority of the information that I hold about you is provided to or gathered by us in the course of your case and/or proceedings. Your solicitor and/or I will tell you why we need the information and how we will use it.

Our Lawful Basis for processing your information

The General Data Protection Regulation (UK GDPR) requires all organisations that process personal data to have a Lawful Basis for doing so. The Lawful Bases identified in the UK GDPR are:

- Consent of the data subject
- Performance of a contract with the data subject or to take steps to enter into a contract
- Compliance with a legal obligation
- To protect the vital interests of a data subject or another person
- Performance of a task carried out in the public interest or in the exercise of official authority vested in the controller.
- The legitimate interests of ourselves, or a third party, except where such interests are overridden by the interests, rights or freedoms of the data subject.

Examples of legitimate interests include:

- Where the data subject is a client or in the service of the controller;
- Transmission within a group of undertakings for internal administrative purposes;
- Processing necessary to ensure network and information security, including preventing unauthorised access;
- Processing for direct marketing purposes, or to prevent fraud; and
- Reporting possible criminal acts or threats to public security.

Our Lawful Basis are consent, compliance contract and legitimate interest and our Legitimate Interest is data subject is a client and direct marketing purposes and reporting possible criminal acts.

I use your information to:

- Provide legal advice and representation
- Keep accounting records and carry out office administration
- Assist in training pupils and mini-pupils
- Investigate and address your concerns;]
- Communicate with you about news, updates and events;
- Investigate or address legal proceedings relating to your use of my services/products, or as otherwise allowed by applicable law;]
- Make statutory returns.
- Comply with my duties and obligations to the court and also with orders of the court.
- To publish legal judgments and decisions of courts and tribunals
- As required or permitted by law.

I do not use automated decision-making in the processing of your personal data. I collect and process both personal data and special categories of personal data as defined in the UK GDPR. This includes:

Client data

- Name;
- Email;
- Phone number;
- Address;
- Payment or bank details;
- Date of birth;
- Location details;
- Device IP address;
- Financial information
- Medical Records
- Criminal Records

I may share your personal data with:

- Instructing solicitors
- Pupil or mini pupil, under my training
- Opposing Counsel or solicitor or litigant in person, for the purposes of resolving the case
- My Chambers management and staff and others who provide administrative and accountancy services
- My regulator or legal advisors in the event of a dispute or other legal matter
- Law enforcement officials, government authorities, or other third parties to meet our legal obligations;
- Any other party where I ask you and you consent to the sharing.
- Head of chambers and other members of chambers who deal with complaints, the Bar Standards Board and the legal ombudsman.
- Current past or prospective employers.
- Education and examining bodies.

Transfers of your information outside the United Kingdom

This privacy notice is of general application and as such it is not possible to state whether it will be necessary to transfer your information out of the UK in any particular case or for a reference. However, if you reside outside the UK or your case or the role for which you require a reference involves persons or organisations or courts and tribunals outside the UK then it may be necessary to transfer some of your data to that country outside of the UK for that purpose. If you are in a country outside the UK or if the instructions you provide come from outside the UK then it is inevitable that information will be transferred to those countries. If this applies to you and you wish additional precautions to be taken in respect of your information please indicate this when providing initial instructions.

Some countries and organisations outside the are recognised under the UK GDPR to provide an adequate level of data protection. Most countries and territories have not been assessed by the UK to provide adequate protection. If your information has to be transferred outside the EEA, then it may not have the same protections and you may not have the same rights as you would within the UK.

I may transfer your personal information to the following countries, which are located outside the European Economic Area (EEA):

- Cloud data storage services based in the USA who have agreed to comply with the EU-US Data Privacy Framework and UK Extension, in order to enable me to store your data and/or backup copies of your data so that I may access your data when I need to. The USA does not have the same data protection laws as the UK, but the EU-US Data Privacy Framework and UK Extension has been recognised by the European Commission and UK as providing adequate protection.
- Cloud data storage services based in countries recognised under the UK GDPR to provide adequate protection, including EU Member States, EEA Member States and Switzerland, in order to enable me to store your data and/or backup copies of your data so that I may access your data when I need to.

If I decide to publish a judgment or other decision of a Court or Tribunal containing your information then this will be published to the world.

I retain your personal data while you remain a [client] unless you ask me to delete it. My Retention and Disposal Policy (copy available on request) details how long I hold data for and how I dispose of it when it no longer needs to be held. I will delete or anonymise your information at your request unless:

- There is an unresolved issue, such as claim or dispute;
- I am legally required to; or
- There are overriding legitimate business interests, including but not limited to fraud prevention and protecting customers' safety and security.

Your Rights

The UK General Data Protection Regulation gives you specific rights around your personal data. For example, you have to be informed about the information I hold and what I use it for, you can ask for a copy of the personal information I hold about you, you

can ask us to correct any inaccuracies with the personal data I hold, you can ask us to stop sending you direct mail, or emails, or in some circumstances ask us to stop processing your details. Finally, if I do something irregular or improper with your personal data you can seek compensation for any distress you are caused or loss you have incurred. You can find out more information from the ICO's website http://ico.org.uk/for_the_public/personal_information and this is the organisation that you can complain to if you are unhappy with how I dealt with you.
